10	<p>In terms of section 11(2) of the immigration Act 13 of 2002, the holder of a visitor's permit may not conduct work, unless authorized by the Director-General of the Department of Home Affairs.</p> <p>"Work" is defined as and includes:</p> <p>(a) Conducting any activity normally associated with the running of a specific business.</p> <p>(b) Being employed or conducting activities, consistent with the profession of the position, with or without remuneration or reward within the Republic of South Africa.</p> <p>Therefore, all persons who do not qualify for work permits or study permits who intend to work on visitor's permit for a period not exceeding 3(three) months must in terms of section 11(2) seek authority from the Director-General.</p> <p>In order for the Embassy to give the authority to conduct work on a visitor's permit (visa), following should be provided:</p>				

<p>The applicant's employer has to explain, in writing, why a standard work permit is not applied for. Reasons must also be provided why the limited work envisaged is urgent and necessary. Furthermore, the applicant's employer in China and the South African company requiring the short term work must give undertakings that they will not apply for extension of the visa or a change of condition. The visa should then be endorsed: "Not to apply for extension/change of condition".</p> <p>根据移民法第11（2）条申请签证（授权持短期签证工作）</p> <p>根据移民法2002年第13章11（2）条的规定，持短期签证者不可以工作，除非有内务部司长的授权。</p> <p>“工作”定义并包含如下内容：</p> <p>（a）从事任何与具体生意运营有关的活动。</p> <p>（b）无论是否有报酬或奖金，在南非境内受雇或从事与本人职业相一致的活动。</p> <p>因此，所有不符合得到工作和学习准证条件者，若要持短期签证从事最多不超过三个月的工作，则要根据第11（2）条的规定得到司长的授权。</p> <p>若要得到持短期签证工作的授权，大使馆需要申请人提供以下材料：申请人的雇主需出具书面说明为何不申请工作准证，同时还需要说明该短期工作需求的紧迫性和必要性的原因。此外，申请人中方雇主和南非邀请方公司必须担保申请人不会在南非申请续签或改变签证状态（种类）。随之签证会标注“不可申请续签和改变状态”。</p>
